INTERNATIONAL WORKSHOP IN LONDON

The 9th Global FM International Workshop was held in London on 13th April, hosted by the annual conference of the British Institute of Facilities Management.

Global FM Chairman Steve Gladwin led the workshop, which centred around the theme "Working across boundaries - the FM challenge in an advancing world". More than 30 participants - representing Global FM member organisations, service companies, software providers and consultancies - discussed the challenges of working across borders to achieve a common goal. Dave Wilson, director of Agents4FM International, set the scene with a thought-provoking presentation on cultural diversity. For him it's all about perception and preconceptions: "*Value judgments based on large groups are of no use when dealing with individuals. Yes, behaviour is partly determined by culture, but personality plays a big part*". Global FM headline sponsor of the International Workshop, Qube Global Software, argued that technology is transcending boundaries. The user interface and expectations of self-service are key components of this trend.

Do international clients want consistency across borders? Yes, said Palle Esbensen of ISS, one of Global FM's 2010 yearly sponsors. Others argued they were not so sure, saying that this might be the view from the CEO/CFO, but that it was unlikely to meet the needs of a local workforce.

In the lively debate (peppered with anecdotes of cross-cultural experiences) the group was divided on whether technology will "normalise" cultures, although all agreed it would be regrettable if diversity was eroded.

BIFM CEO Ian Fielder suggested that the word not used in the debate so far was "community." He argued that all diversity issues could be transcended by observing the culture of younger people and the ease with which they build networks, i.e., via LinkedIn and Facebook. Changes were evident within the BIFM, said Fielder, as members were more in-

clined to build a community of interest with like-minded people than to support a geographical bond. If the diversity of opinion in the room was anything to go by, there is certainly no danger of cultural conformity in FM just yet.

Dani Kolb, Global FM Headquarters (Kellen Europe), highlighted the fact that today it is common practice for young people to study and work in different member states of the European Union. This mobility has broken down boundaries and will probably do so even more in future. Following the event, Steve Gladwin highlighted the positive outcome of the workshop and the lively discussion: *"Thanks to a diverse audience, we were able to share our views on the challenges that new information technologies and communications are posing to the FM profession, companies and associations. Global FM is a living example of how to work and co-operate across boundaries."*

During the BIFM annual conference, Global FM had a very successful face-to-face board meeting. The board worked on the organisation's Balanced Scorecard and strategic direction



WINNERS FOR THE AWARDS FOR EXCELLENCE IN FM

The Global FM Awards for Excellence in Facilities Management recognise efforts by individuals or teams within the FM industry, from researchers to facilities operators, who have made a positive contribution to the knowledge, practical application and communication of strategies to improve the workplace environment and sustainable performance of their facilities.

These awards are intended to recognize the “best-of-the-best” within the FM world and promote the strategic value and progress of facilities management. They give an invaluable worldwide recognition to recipients for their commitment and success in promoting and enhancing facilities management practices.

The recipients of these awards demonstrated the value of their innovations and/or improvements to the community through sustainable outcomes in the FM industry. The innovations and/or improvements arose from research or an initiative. They were in turn substantiated by supporting documentation or independent verification of the outcomes of the initiative, or in the case of research, the key findings.

The three levels of recognition awarded included:

- § The Platinum Award for Excellence in FM
- § The Gold Award for Excellence in FM
- § The Silver Award for Excellence in FM

Global FM received 13 award submissions and proudly announced the following winners on World FM Day:

WINNERS FOR THE AWARDS FOR EXCELLENCE IN FM

THE PLATINUM AWARD FOR EXCELLENCE IN FM WINNER EC HARRIS & DEPARTMENT FOR CHILDREN, SCHOOLS & FAMILIES



EC Harris is an international built asset consultancy in planning and executing strategies that optimise the construction, operation, use and ownership of built assets.

DCSF (Department for Children, Schools & Families, now called the Department for Education) had several buildings which were old fashioned, inefficient and based around cellular offices. Together with EC Harris they committed to improve the work environment while

improving the sustainability performance with minimal environmental impact.

DCSF and EC Harris developed a plan which:

- § Reduced desk space ratio;
- § Created greater use of natural light in meeting rooms;
- § Offered more height adjustable desks to meet individual needs;
- § Reduced the DCSF's carbon footprint by 50 percent in London through multiple energy efficiency improvements; and
- § Had energy efficiency improvements resulting in ongoing FM savings of 1.5M Euros per annum.

Most of the occupants reported that while they appreciated the cost savings, the changes also improved their ability to collaborate. In addition, they noticed better operational effectiveness. This award is a shining example of how FM teams can think into the long term operations and see the beneficial impact of project design and planning to improve the workplace, save money and reduce the carbon footprint of the organisation.

THE GOLD AWARD FOR EXCELLENCE IN FM WINNER CISCO FRANCE & OZ CONSULTING



CISCO France (Paris) forecasted a 40 percent growth from 2008 to 2012. The project presented by Cisco France is the result of a need to adapt the workplace environment to new ways of working. The main objectives were to support the business growth, to achieve a flexible and comfortable working environment in a

competitive environment, to create next generation working facilities, to make the building a CISCO technology showcase, and to reduce CO₂ emission.

In partnership with OZ Consulting, the existing Cisco 11,300 m² office has been renovated using the concept of mobility to achieve a more intelligent use of space. Cisco and OZ Consulting worked on mobility to bring new opportunities to transform the workplace into a more collaborative, productive and environmentally-conscious place that will meet business and operational needs. This concept has been implemented along with the promotion of the brand and in-house technology.

As a result, satisfaction rate has increased from 49 to 57 percent and occupancy rate from 41 to 54 percent.

THE SILVER AWARD FOR EXCELLENCE IN FM WINNER THE CENTER MILTON KEYNES, UK

thecentre:mk is a regional shopping centre situated in the heart of Milton Keynes. With over 240 stores, cafes and restaurants all under one roof, it is anchored by John Lewis, House of Fraser, Marks & Spencer and Next. As the premier shopping destination in the region between London and Birmingham, Cambridge and Oxford, thecentre:mk enjoys around 30 million visits every year and is unrivalled in its customer service.

The initial factors which prompted the research into biodiesel were the increasing cost into diesel and a desire to minimise the CO₂ emissions generated by vehicles. In choosing to use tenants' waste cooking oil, the FM team also discovered there are other operational benefits. The overall emissions generated from the collection, processing and disposal of the byproducts of the waste cooking oil at thecentre:mk is 1.258 kg of CO₂ eq. per litre of biodiesel produced. This figure represents a 52 percent reduction in the emissions factor to that of petroleum diesel when directly compared. It is a considerable decrease for thecentre:mk.

During the initial phases of testing, biodiesel was gradually introduced to the vehicles and a saving of around £60 a month was realised. This saving is now closer to £150 a month - giving a payback period of 20 months.

INTERNATIONAL WORKSHOP IN ATLANTA

The workshop "Managing FM Across Borders" will be held one day prior to IFMA's World Workplace 2010 Conference & Expo, in Atlanta, Georgia, at the conference hotel, from 9:00 to 12:00. Increased interdependence of world markets is accelerating the rate of change taking place in the facility management profession. In the past, only those facility professionals who were responsible for real property or fixed assets in multiple countries had to think globally. Moreover, this elite group was largely comprised of senior practitioners who were a part of, or had direct access to, top management and the C suite. Many had MBAs for guidance and vast international experience on which to rely. Today virtually every facility professional, regardless of location or experience, must operate in a business environment that is more global than ever before. A facility professional need not have a physical presence outside his or her vicinity to be considered an international player. Companies are bought and sold across borders, suppliers change from domestic to international, products are launched in new markets throughout the world and any company or organisation with a presence on the Internet is global. This is the last of the two planned workshops in 2010 to explore the challenges and opportunities that cross border delivery facilities management faces and to look at practical and repeatable solutions.

Workshop objectives:

- § What macro factors are changing the global landscape for facilities managers?
- § What cultural, age, geographic boundaries exist that must be identified and addressed?
- § How are FM practitioners responding to these changes - both in their approaches to strategic facilities planning and day-to-day operations?

- § What collaboration is taking place?
- § What current offerings can assist FMs in both preparation and implementation?
- § What is around the corner and how can we collectively prepare for it?
